

Documents Needed to Complete FAFSA: Free Application for Federal Student Aid

For Students Attending College Fall of 2021 & Spring of 2022

The FAFSA is a signed legal document sent to the U.S. Dept. of Education and filtered through many data bases to be sure the information you give is correct. For us to help you be the most accurate, we have provided a list of the data required. If some items do not pertain to you or your family's situation, do not worry about gathering that information.

<input type="checkbox"/> Yours and Your Parent(s) Permanent Resident Card Number (if you are not a U.S. citizen)
